#### **ADMINISTRATIVE SESSION**

1. Real Property Exemption – Avilton Community Association

Avilton Community Association – Request for Fiscal Year 2025 County Property Tax Abatement granted under the Annotated Code of Maryland, Section 9-313.

The Board of County Commissioners, on a motion by Commissioner Savage, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved a real property exemption for Fiscal Year 2025 for the Avilton Community Association.

- 2. **Board Appointments/Reappointments** The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Savage, and made unanimous by Chairman Edwards, appointed/reappointed the following individuals:
  - Garrett County Mental Health Advisory Committee Appointment of Jessica Savage as the Social Services Representative to fulfill the unexpired term of Heather Bosley who resigned from her position. Term will expire June 30, 2026.
  - ❖ Garrett County Planning Commission Reappointment of Elizabeth Georg for a 5-Year Term. Term will expire February 4, 2029.
- 3. Mr. Null reviewed a number of administrative and managerial matters under his authority and jurisdiction with the Board of County Commissioners.

Hannah Snyder, Assistant Development Director, Tucker Community Foundation, reported that in 2023, the Board of County Commissioners donated \$2,000 which resulted in \$48,150 in donations and scholarships to local non-profit groups and requested the Board consider donating again this year. Chairman Edwards stated that the Board would take the request under advisement. Request for consideration for a donation of \$2,500.
