APPROVAL OF MINUTES:

ELECTION DIRECTOR REPORT:

There were 102 new registrations and 47 removals in May. Active registered voters are as follows for Garrett County: Democrat – 3,757, Republican – 13,563, Green Party – 26, Libertarian – 100, Working Class – 20, Unaffiliated – 2,830, and other parties – 167, for a total of 20,463.

On June 20th the office will be closed in observance of Juneteenth.

June 28th is the close of voter registration. The office will be open until 5:00 p.m.

On July 4th the office will be closed in observance of Independence Day.

NEW BUSINESS AND CORRESPONDENCE:

Steve presented to the Board the following information relating to the 2022 Gubernatorial Election:

- 1. Copies of the Republican, Democrat and Non-Partisan ballots have been posted on our website, www.garrettcounty.org/board-of-elections.
- 2. The Specimen Ballot information has been forwarded to the printing company. The tentative date for delivery to all registered voters is June 27th.

- 3. Mail-in-Ballots
 - a) 1,368 Mail-in-Ballot applications has been received to date.
 - b) Voters will start receiving their mail-in ballots beginning June 13th.
 - c) Drop boxes for mail-in ballots will be delivered on Monday, June 13th.
- 4. Logic and Accuracy Testing
 - a) Steve and Julie, (County Technician), will start Logic and Accuracy on Tuesday, June 14th on the Ballot Marking Devices.
 - b) On Wednesday, June 22nd the Board and staff will begin Logic and Accuracy on the DS200's.
- 5. Election Judges
 - a) Recently 7 new election judges were hired, with 5 being early voting judges only. An additional judges training was held June 1st for the 7 new judges and the 2 judges that missed the prior trainings.
 - b) Election Judge assignments were mailed to all judges on June 3rd.
- 6. Kerry Gibson, Clerk of Courts, will administer the Oath to the Board on June 22nd at 10:00 a.m.
